**Premises –** Thank you to Steve Prance (LSA governor) who has been working closely with Laura Concannon to ensure we are working towards and achieving our premises 'To Do' list. The new entry door system is now in place and working well and has enabled us to improve our safeguarding further along with improved efficiencies. Work will be underway to tarmac the main entrance to the playground, as the slabs are uneven and need to be replaced. The team will continue to look at other works and improvements needed and schedule these when viable.

#### Standards and Achievements -

As expected, we received our OFSTED inspection in May. The report has been circulated, along with the additional information from the debrief meeting. If you have not yet read this, please do take the time to do so. We were thrilled with the outcome, which showcased the hard work and commitment from Mrs Concannon and the whole team. It has also provided some focused areas for development which are already underway.

Statutory assessments have also been extremely successful this year with St Mary's exceeding the national average by quite some margin. Maths 9% above and English 18% above. Congratulations to all KS2 children on their achievements.

#### Governor Monitoring -

We have had several governor visits during the term. The main visit in June was to review the progress in writing across the school. The teaching team have been working hard to increase both writing endurance and quality. As always it was a joy to visit the school and a privilege to observe classes, overall, it was very clear to see the consistent approach to delivery across all year groups. Children were supported well with scaffolded activity, appropriate to their age and ability, to ensure confidence and success in the task. There were high expectations of the children in all year groups, and they were working on complex tasks. Children made good progress in their writing, they knew how to improve and their next steps. Whilst we were not monitoring pupil behaviour, we did note that this was exemplary, pupils were kind, helpful and worked hard.

We also conducted a safeguarding visit, which did not highlight any issues and will feed in the general report and tasks list.

#### Academisation -

Having met with the 2 trusts as documented in my last newsletter, we have now been approached by the diocese to consider a third option. We are waiting for dates from the diocese to meet with them and go through this in more detail, which I will share with you as soon as I am able

Please rest assured throughout the decision process the core values and ethos of St Mary's will be upmost in our minds, ensuring that the entire St Mary's community, staff, pupils, and parents are at the centre of our decision making. We will ensure both staff and parent information evenings are built into the process, to keep you fully informed. We have been assured by both Trusts that there will be very little change to school life for pupils, families and staff
